Eligibility

Diploma/Bachelors/Master's degree in Engineering/Science with relevant work experience in the field of measurements either in maintenance, inspection, testing/calibration laboratory or QA.

Certification

It is mandatory to attend all sessions of the programme and the “**Training Certificate**” will be given only for the successful participants.

Course Fee

Rs. 14,160/- (inclusive of GST @18%) per participant. Fee includes course materials, working lunch and tea breaks. The Course Fee to be paid in advance by NEFT (A/c.
